Re: Core funding of MHFI by GSK

1. Organisation

The Men's Health Forum in Ireland (MHFI) works on an all Ireland basis to enhance the health and wellbeing of men and boys through research, advocacy, training, networking and demonstration projects.

2. Sponsorship

GlaxoSmithKline Services Unlimited ("GSK") is pleased to confirm that it will provide financial support to the Men's Health Forum in Ireland (MHFI) on an annual basis for the duration of two years, commencing in 2010. This agreement will commence in November 2010 and terminate at the end of 2011, unless otherwise renewed by mutual agreement.

3. Objectives

MHFI will use the core funding provided by GSK to part-support a worker to coordinate MHFI operations, and will use this financial assistance as a lever to generate additional funding for a full-time position.

4. Payment

The annual funding will be 10,000 Euros, to be paid - following receipt of a VAT invoice from MHFI - directly to MHFI's bank account. The payment will be made by bank transfer to:

5. GSK Recognition

MHFI will include acknowledgement of GSK's financial support on MHFI publications and communications for the duration of this Agreement.

6. Use of Logo

Neither the MHFI logo nor the GSK logo should appear on the other party's written materials, or in on-line information, without the written permission of the party owning the logo.

7. Confidentiality and Data Protection

Confidentiality of information received in the course of any arrangement between GSK and the MHFI will be respected by the party receiving the information and never used outside the scope of the arrangement.

8. Publication of GSK Working Arrangements

GSK shall comply with the requirements of both the IPHA Code of Marketing Practice and the ABPI Code of Practice and its own internal codes of practice to ensure that all involvement with MHFI will be declared on the GSK UK web site and, in the case of GSK Ireland, be published in a booklet annually available on request, including the percentage which GSK's funding represents for MHFI. MHFI will, at GSK's request, provide information which GSK may need to enable it to calculate the percentage for its website.

9. General

In providing this financial support, GSK will respect the independence of MHFI and its medical, political and social judgment. Through a mutual and open understanding of each other's objectives and working practices, GSK will demonstrate probity and good governance.

Nothing in this Agreement shall prevent MHFI from working with any third party, company or organisation, and MHFI shall be at liberty to disclose that it is working with GSK to such other party.

This Agreement will be governed in all respects by Irish and UK law, and the parties hereby submit to the exclusive jurisdiction of the Irish and UK Courts.
